

IV Class Offerings

Central Line Review-3 hours long

This class offering is ideal for the nurse who has had experience with peripheral and central lines and needs a refresher. Similar to the 6 hour class, but focuses mainly on central line guidelines and techniques. Includes theory provided via power point presentation as well as written test with required grade of 80% or greater. Competency validation of the nurse is encouraged and should be done by DON/designated staff on a resident in the facility after completion of the class.

No CEU's but will receive a certificate of training for the nurses file.

Cost \$50/per nurse. Charge will show up on pharmacy invoice.

Back to Basics-6 hours long

This class offering is ideal for the nurse who has very limited knowledge/skill in peripheral and central lines. Designed for LPN's.

Basic principles of intravenous therapy. Practice guidelines, techniques and technology will be presented. Fluid and electrolytes, Anatomy and physiology, Complications IV fluids, Drug Calculations, Documentation, Indications for therapy, etc. Includes theory provided via power point presentation, skills practicum and written test with required grade of 80% or greater. A competency validation checklist will be provided to the DON. It is not necessary to use this list but is only offered for your convenience.

This class offers 6 hours CEUs in addition to a certificate of training for the nurses file.

Cost \$50/per nurse. Charge will show up on pharmacy invoice.

- -Nurses attending this class should not be on the schedule to work during the hours of training as this interrupts the learning process.
- -Bring lunch/snacks. Breaks will be provided at students' discretion.
- -Class can be taught at a location of your choosing as long as there is a blank wall for power point presentation and adequate seating for the attendees.

Arkansas State Board of Nursing Practice Guidelines for LPNS and IV Therapy. "for the LPN to perform this delegated task, post-grad educaton and competency validation must be obtained. The nurse shall be competent in the safe delivery of infusion therapy within his or her scope of practice. The nurse shall be accountable for attaining and maintaining competency with infusion therapy within his/her scope of practice according to state law and facility policy.

It is up to each nurse to know what his/her license allows them to do and any questions regarding scope of practice should be referred to the State Board of Nursing in which the nurse is practicing. Competency validation Is done by facility DON or other designated facility staff after completion of class.

Hypodermoclysis-2.5 hours long

This technique is an alternative to peripheral infusions for mild to moderate dehydration. No medication can be infused. Hydration fluids only. This class offering will train nurses on hydration technique via subcutaneous route. It is a useful and easy hydration technique for the adult (especially elderly) patient.

\$100/per class. No limit on number of attendees. Charge for class will show up on pharmacy bill.

TPN-3 hours long

This class will focus on a method of feeding that bypasses the GI tract. Fluids are given into a vein to provide most of the nutrients the body needs. This method is used when a person cannot or should not receive feedings or fluid by mouth.

\$100/per class. No limit on number of attendees.
